Brief Summary: The EPC Legal Department provides a monthly summary of its ongoing civil, appellate, and

administrative matters.

Financial Impact: No Financial Impact anticipated.

Background: In an effort to provide the Commission with timely information regarding legal challenges, the EPC staff provides this monthly summary. The update serves not only to inform the Commission of current litigation but may also be used as a tool to check for any conflicts they may have in the event a legal matter is discussed by the Commission. The summary provides general details as to the status of the civil and administrative cases. There is also a listing of cases where parties have asked for additional time in order to allow them to decide whether they will file an administrative challenge to an agency action (e.g. – permitting decision or enforcement order), while concurrently attempting to seek resolution of the agency action.

EPC LEGAL DEPARTMENT MONTHLY REPORT March and April 2016

I. ADMINISTRATIVE CASES

<u>Donna K. McClellan</u> [16-EPC-001]: On February 23, 2016, the Appellant filed a Notice of Appeal challenging the issuance of Miscellaneous Activities in Wetlands (MAIW) Authorization #60254. The Appeal was determined to be insufficient and an Order Dismissing Appeal with Leave to Amend was issued. The Appellant had until March 15, 2016 to file an Amended Appeal. No Amended Appeal was filed and the case is closed.

J.E. McLean, III and RaceTrac Petroleum, Inc. [12-EPC-014]: On October 24, 2012, the Appellants, RaceTrac Petroleum, Inc. and the property owner, filed a request for an extension of time to file an Appeal challenging the Executive Director's denial for wetland impacts on the corner of Lumsden and Kings Avenue. The extension was granted and the Appellants filed an appeal in this matter on December 7, 2012. A Hearing Officer has been assigned and conducted a case management conference. This matter was placed in abeyance as the parties discussed options. A conceptual wetland impact approval letter was sent to the applicant on December 8, 2015 after a modification to the application was submitted. The parties will wait for the time period to challenge the new agency action and if no appeals are submitted the matter should be closed.

II. CIVIL CASES

Volkswagen AG, et al. [16-EPC-002]: On March 24, 2016, the EPC filed a complaint against Volkswagen AG, et al. for activities that violate the EPC Enabling Act and the rules promulgated thereunder.

Bank of NY Mellon Trust [15-EPC-012]: On December 4, 2015, the Bank of NY Mellon Trust Company National Association served upon the EPC a Verified Complaint for Foreclosure of Mortgage naming EPC as a Defendant in the matter

There is a bankruptcy stay regarding this matter and the case will remain in abeyance until further action in Bankruptcy

<u>Janet Laver</u> [15-EPC-009]: In December of 2015 the EPC Commission authorized staff to take appropriate legal action against Ms. Janet Layer for failure to comply with various wastewater regulations regarding her operation of the domestic wastewater treatment plant and disposal system at Little Manatee Isles Mobile Home Park in Ruskin.

- <u>U.S. Bankruptcy Court in re Jerry A. Lewis Adversary Proceeding</u> [15-EPC-007]: An Adversary Proceeding pertaining to the ongoing Chapter 13 Bankruptcy Case regarding Jerry A. Lewis (see EPC Case No. LEPC09-011) was entered on October 9, 2013, in the U.S. Bankruptcy Court Middle District of Florida. EPC is defendant in the matter and will seek to protect a monetary judgment awarded to us by the Circuit Court.
- <u>U.S. Bankruptcy Court in re Jerry A. Lewis</u> [LEPC09-011]: On May 1, 2009, the U.S. Bankruptcy Court Middle District of Florida filed a Notice of Chapter 13 Bankruptcy Case regarding Jerry A. Lewis. On May 26, 2009, the EPC filed a Proof of Claim with the Court. The EPC's basis for the claim is a recorded judgment lien awarded in Civil Court against Mr. Lewis concerning unauthorized disposal of solid waste. The EPC obtained an award of stipulated penalties from the state court. The site remains out of compliance with applicable EPC solid waste regulations and no liens have been paid. The bankruptcy case is ongoing.
- Grace E. Poole and Michael Rissell [LEPC08-015]: Authority to take appropriate legal action against Grace E. Poole and Michael Rissell for failure to properly assess petroleum contamination in accordance with EPC and State regulations was granted on June 19, 2008. The property owner and/or other responsible party are required to initiate a site assessment and submit a Site Assessment Report. They have failed to do the required work and the EPC is attempting to obtain appropriate corrective actions.
- **Boyce E. Slusmeyer** [LEPC10-019]: On Sept 20, 2001, the EPC staff received authority to take legal action for failure to comply with an Executive Director's Citation and Order to Correct Violation for the failure to initiate a cleanup of a petroleum-contaminated property. The Court entered a Consent Final Judgment on March 13, 2003. The Defendant has

failed to perform the appropriate remedial actions for petroleum contamination on the property. The EPC filed a lawsuit on October 7, 2010 seeking injunctive relief and recovery of costs and penalties. The EPC is waiting for the lawsuit to be served.

Thomas Jennings and Lorene Hall-Jennings [14-EPC011]: On October 7, 2014, the EPC was served with a Declaratory Action challenging the validity of a conservation easement conveyed to the EPC on September 16, 1997. The EPC Legal Department has responded to the lawsuit with an Answer and Affirmative Defenses on October 27, 2014 and the case will move forward as appropriate. On October 12, 2015 the Plaintiff filed a Motion for Judgment on the Pleadings. The EPC responded to the Motion on October 21, 2015. The case is on-going.

III. PENDING ADMINISTRATIVE CHALLENGES

The following is a list of cases assigned to the EPC Legal Department that are not in litigation, but a party has asked for an extension of time to file for administrative litigation in an effort to negotiate a settlement prior to forwarding the case to a Hearing Officer. The below list may also include waiver or variance requests.

Subject: Presentation on Florida Conservation & Technology Center (FCTC) and the Center for Conservation

(CFC)

Agenda Section: Regular Agenda

Division: Legal and Administrative Services Division

Recommendation: This is an informational report.

Brief Summary: Representatives from Tampa Electric will give a brief update on activities at the Florida Conservation & Technology Center, and the Florida Aquarium representatives will speak to the Center for Conservation. Both are located at the 500 acre site in Apollo Beach and have a goal of bringing in one million visitors a year.

Financial Impact: No Financial Impact.

Background: Following a stakeholder meeting last fall at the FCTC, EPC staff was so impressed they asked TECO to share their success story with the EPC Board. The FCTC is a 500 acre site immediately south of their Big Bend power plant and owned by TECO. It includes the Manatee Viewing Center, the Energy Technology Center, a Welcome Center, and the Florida Aquarium and Florida Fish and Wildlife Conservation Commission's CFC. The latter sits on twenty of the five hundred acres and is leased from TECO.

Representatives from the two organizations will speak to the ongoing activities on the site. Their goal when finished is to bring one million eco-tourists to the site every year.

Brief Summary: EPC staff submitted an application to the Florida Sterling Council last November for the GSA and we had an on-site audit with seven examiners lasting six days. While they were generally very complimentary, they did identify some opportunities for improvement which will be detailed in a report we expect to receive next month. We would also hear at that time if the Agency achieved the GSA winner's designation. This update will be limited to what we know at this point.

Financial Impact: No Financial Impact cv'y ku'vo g.

Background: In November of 2015, EPC staff submitted a fifty page GSA application to the Florida Sterling Council. Following numerous teleconferences and several requests for additional information, EPC hosted seven auditors over six days last month as they looked closely at our operations. They gave us an out briefing at the conclusion of their visit and we will share some of that with the Board.

EPC's Sterling journey started six years ago and has led to the development of a formalized planning and tracking process. The Agency now tracks some sixty metrics and benchmarks against other high performing organizations to set short and long term goals.

The ultimate outcome is better protection of our natural resources, improved service for our customers and more efficient use of our resources. All this is in the pursuit of continuous improvement. So the journey doesn't end because the Agency submitted an application for the highest achievement under Sterling, but it simply helps the EPC get better at everything we do.

Subject: EPC's FY 17 Business Opportunities

Recommendation: Ask EPC Board to vote to direct staff to hold a technical workshop regarding the fees in

Chapter 1-6.

Brief Summary: As part of the budget application process for FY 17, EPC committed to look at various business opportunities to offset any general fund impacts. One of those business opportunities includes revisiting EPC's user fees schedule. Staff has not brought the whole fee schedule to the EPC Board since 2011, and it has not been updated since 2003. Following a brief presentation, staff will ask the EPC Board for direction through a vote on whether to host a technical workshop on the subject.

Financial Impact: No Financial Impact at this time.

Background: The EPC Board approved a user fee schedule for specific services back in 1985. Since then the Board has amended it on numerous occasions. The last wholesale update was in October of 2003. These fees are deposited directly into the general fund and help offset the cost of the Agency. Annually they account for approximately \$1.6 million dollars in revenues.

In 2011, the EPC Board held a public hearing regarding the fees in Chapter 1-6 and decided to take no action. Now five years later we are asking for the Board's direction regarding this business opportunity for FY 17. If the Board does want to look at the fees in more detail, the first step would be to hold a staff level technical workshop. Once the workshop is held with the stakeholder groups, staff would report back to the Board where they could decide whether to authorize a public hearing to change the fees.

Options considered in 2011 included taking no action to looking at new fees or simply limiting it to adjusting the existing fees to reflect the change in the Consumer Price Index since 2003.

Brief Summary: Once again this year, EPC is celebrating the month of May as Clean Air Month. On May 5, 2016, EPC will be hosting the *15th Annual Clean Air Fair* in downtown Tampa. The *Clean Air Fair* is the signature public outreach event annually organized by EPC, and is typically attended by over an estimated 800 visitors each year. EPC is also hosting the *15th Annual EPC Clean Air Month Photo Contest* in conjunction with the Hillsborough County School System. The winning photographs will be displayed at the *Clean Air Fair*.

Financial Impact: No Hinancial Impact.

Background: Starting in 2000 EPC embraced the celebration of the designation of the month of May as Clean Air Month through the hosting of community events, environmental presentations to local schools, and promotion of environmental contests. EPC is proud to continue recognition of Air Awareness through two primary public outreach activities.

On May 5, 2016, EPC is pleased to host the award-winning *Clean Air Fair* for the 15th consecutive year at Poe Plaza in downtown Tampa from 11:30am-1:30pm. EPC established this year's theme for Clean Air Month as:

It is intended to remind us that the air we all share recognizes no boundaries and it is vital that we communicate the importance of clean air and a healthy environment to all cultures and generations. The goal of the fair is to highlight local air quality and to promote a healthy environment through public education. Each year, the event seeks to recognize environmentally-conscious organizations and companies that contribute towards making our community a better place to live. The free lunchtime event is scheduled to include a variety of environmental and health information, complimentary refreshments and food items, giveaways, prize drawings and live music.

EPC will also be recognizing Arbor Day at the *Clean Air Fair*. Although the national designation is April 29th, EPC partnered with the Florida Forest Service to acquire funding that will allow for complimentary saplings of various trees to be distributed at the event. The winners and selected honorable mentions will also be displayed at the Clean Air Fair, and are scheduled to be showcased in the lobbies of county center and EPC.
