Description/Summary:

In response to a request by the EPC Board at its January 20, 2000 meeting, EPC staff was asked to present a briefing on issues associated with the proposed desalination facility to be located at Big Bend. The briefing is to take place during a special meeting of the EPC on February 2, 2000 during the regularly scheduled BOCC meeting. Topics for

1) The NEPA Environmental Impact Statement (EIS) process,

2) Opportunities for enrolling the desalination facility in the EIS process,

3) Cumulative impacts on Tampa Bay associated with Tampa Bay Water (TBW) projects and the desalination facility, including existing and proposed studies, and

4) Courses of action to be taken with regard to evaluating the desalination facility.

Regulatory agencies involved in review of the desalination plant application, the Hillsborough County Water Resource Team, and the USEPA will be asked to have representation at the meeting to facilitate response to EPC Board questions.

Description/Summary:

On Tuesday, January 25, 2000, the SWFWMD Governing Board adopted the February, March and April 1999 version of the above rules following a presentation of the Independent Scientific Peer Review report. The deadline to file a challenge is close of business Friday, February 4, 2000.

EPC staff has reviewed the subject rules in light of the findings and our own analysis. Although we continue to have concerns regarding specific issues, EPC staff believes that a 120 challenge at this time is not necessary to protect the public interest.

Commission Action Recommended:

Recommend Board concurrence that EPC not file an administrative challenge to the Lower Hillsborough River Minimum Flow rule.
