**Brief Summary:** This notification is to assist Commissioners in identifying potential conflicts of interest that may exist and that may require disclosure prior to taking action in a quasi-judicial administrative matter. It is also intended to assist Commissioners in avoiding discussing matters with parties during administrative or civil litigation.

**Financial Impact:** Standard litigation costs are included in the Legal Department's operating budget, but any individual case may require a future budget amendment.

List of Attachments: None

**Background:** The EPC Legal Department primarily handles litigation in administrative and civil forums. A list of <u>new</u> cases the EPC opened since the previous Commission meeting is provided below. Occasionally, a new case or cases, may be disposed of in between the prior and current EPC meetings, yet this list will still be provided for continuity and consistency.

Administrative appeals (a/k/a administrative hearings, petitions, challenges, or Section 9 Appeals) involve challenges to agency actions such as permit application decisions or administrative enforcement actions (e.g. – citation or consent order). These proceedings are conducted before an appointed hearing officer who enters a recommended order after an evidentiary hearing. After the hearing officer issues the recommendation, the administrative appeal is transferred back to the Commission to render a final order. Acting in this quasi-judicial capacity, the Commission and all parties are subject to ex-parte communication restrictions. After receipt of an appeal or a request for an extension of time to file an appeal, the Commission should avoid discussing those cases. The chart below generically refers to these cases as "Administrative Appeal," but it could also be an extension of time to file an appeal.

The purpose of providing notice of new cases is to assist Commissioners in identifying persons or entities that may present a conflict of interest. Certain conflicts may require the Commission to recuse themselves from voting on a final order. Please note, the Legal Department provides notice of sufficient

appeals to the Commission via e-mail to assist in the conflict check process and as a reminder to limit communications; therefore, the Commission may have already received prior notification of the administrative case(s) listed below.

If the EPC becomes a party in civil litigation either through an approved Request for Authority to Initiate Litigation or by receipt of a lawsuit, the case will also be listed below. Any attorneys representing opposing party(ies) must communicate through the EPC counsel and should not contact the Commission directly. It also recommended that the Commissioners avoid discussing litigation prior to consulting with EPC counsel.

Subject: Pay Range Adjustments

**Recommendation:** Adjust the maximum pay ranges by 7% for all EPC classified employee pay ranges.

**Brief Summary:** Based on reviews of market salaries and inflation and to retain highly skilled personnel, we are requesting a 7% adjustment to the maximum of all EPC classified employee pay ranges. No employees are receiving additional salary if this is approved, it will just allow them to have room for future pay increases.

Financial Impact: No Financial Impact

Background: In July 2022, Hillsborough County administration adjusted their minimum and maximum pay ranges to accommodate for the 3% Cost of Living Adjustment (COLA) increase approved by the BOCC. Similarly, in July 2022, EPC minimum and maximum pay ranges were adjusted by 3% to parallel Hillsborough County's COLA actions. Even with this COLA, many experienced staff are close to or at the maximum of their pay range. The Employment Cost Index Summary indicates wages and salaries have increased 4.6 percent for state and local government workers in public administration for the 12-month period ending in June 2022. As of October 13, 2021, the annual Cost of Living Adjustment was determined by the Social Security Administration at 5.9 percent. Based on these recent studies and inflationary pressures, we are requesting a 7% increase to the maximum rate of all EPC pay ranges to assist in retaining highly skilled personnel and limit staff salaries being "red-lined." This would not adjust the minimum range, just the maximum range. Thus, employees are not receiving salary adjustments if this is approved, it will just allow employees to have room for future pay increases. A chart of pay ranges is included below.

**Background:** EPC staff is currently reviewing Chapter 1-10 (Noise), Rules of the EPC, for possible revision and will present recommendations for the Commission's consideration within the next few months. Leading up to a final recommendation, EPC staff will conduct internal meetings with operational and legal staff, consult with a noise expert and meet with stakeholder organizations such as the City of Tampa and Hillsborough County Code Enforcement before developing a recommended rule that will be based on science and practical applicability. #### **Background:**

Chapter 1-2, Rules of the EPC is the EPC's Administrative Procedures Rule. Among other things, the rule provides procedures on how to challenge EPC agency actions (e.g., permits), how to apply for a variance, public noticing of EPC actions, and rulemaking procedures. The rule was last revised in August of 2012. At a minimum, the Legal Department proposes to update antiquated references, clarify administrative appeal procedures, adopt updated rules of judicial procedure, and provide permit application completeness criteria. We anticipate it will be a few months before a draft will be ready for Commission consideration.

The EPC Act only requires the EPC to conduct a public hearing at the time of rule adoption, but EPC staff will also conduct non-mandatory stakeholder workshops as needed. The EPC staff is informing the Commission that it will conduct public workshop(s) and set a public hearing before the Commission to consider amendments to Chapter 1-2, Rules of the EPC – Administrative Procedures Rule. This is an informational report, no vote is required to initiate rulemaking.

Subject: Request for Pollution Recovery Funds to Sample and Assess Petroleum Contamination

**Recommendation:** Authorize the EPC to expend up to fifteen thousand dollars (\$15,000.00) of Pollution Recovery Funds to hire appropriate entities to conduct sampling and assessment of petroleum contamination on property located adjacent to 7702 Morning Glory Lane in Tampa.

**Brief Summary:** Paul Heckman was the owner of property located at 7702 Morning Glory Lane, Tampa, Florida (Property) between 2002 and 2004. Mr. Heckman also owned a truck that would be frequently parked adjacent to the property. In August 2002 there was a spill of diesel fuel from the saddle tanks of the truck while it was parked in an area adjacent to the road but outside the surveyed boundary of the Property. Hillsborough County Real Estate Department confirmed that the area is not owned by Hillsborough County. The soil has been removed but additional sampling is required to verify the site is clean and the case closed. No appropriate responsible party remains as Mr. Heckman can no longer be found and the discharge of petroleum product occurred on property with no clear owner. EPC staff is proposing to use Pollution Recovery Fund monies to complete the assessment of the site.

**Financial Impact:** No financial impact on general funds. Cost to the Pollution Recovery Fund is estimated to be less than fifteen thousand dollars (\$15,000).

**Background:** On August 27, 2002, Department of Environmental Protection Bureau of Emergency Response (BER) investigated a leak of diesel fuel on a property adjacent to property owned by Paul Heckman at 7702 Morning Glory Lane in Tampa (Property). The BER incident summary report stated that the truck owned by Mr. Heckman had been parked on an incline and fuel leaked out and discharged into the environment. The discharge occurred on property adjacent to the road but outside the surveyed boundary of the Property. Hillsborough County Real Estate Department confirmed the area is not owned by Hillsborough County. The responsible party at the time removed approximately 14 cubic yards of soil and properly disposed of the contaminated soils. BER referred this incident to the EPC to ensure that proper cleanup procedures were undertaken by any responsible parties.

Several correspondences were sent to Mr. Heckman between 2002 and 2004 advising that a Site Assessment (SA) must be initiated within 30 days and two copies of a Site Assessment Report (SAR) must be submitted within 270 days. Mr. Heckman submitted documentation supporting a claim of financial inability to pay for the assessment. Mr. Heckman later filed for bankruptcy protection and either sold or lost the Property in 2004. The soil has been removed but additional confirmatory sampling is required to verify the site is clean.

Since that time the EPC staff have attempted to work with Hillsborough County Real Estate or the adjacent property owner to obtain the required assessment information. The EPC staff have determined that Hillsborough

County and the adjacent property owner are not financially responsible to complete the work. In addition, Mr. Heckman can no longer be found and there is no other responsible party available to complete the nominal amount of work. It is anticipated that this additional sampling will verify the site is clean (the verification is required to be completed by State law) and the case can be closed. The PRF funds are to be allocated to the EPC to make the arrangements to complete the required assessment.

#### **Background:**

Commissioner Hagan asked the Environmental Protection Commission of Hillsborough County (EPC) staff to give a presentation on a pending application for an air curtain incinerator (ACI).

Under our permitting delegation from the State of Florida Department of Environmental Protection (FDEP), the EPC is processing an application for a new air pollution source under applicable State laws. Specifically, it is an air construction permit application (Application No. 0571488-001-AC) from Louis Geraci, LLLP, for the construction of two ACIs to burn vegetative yard waste and land clearing debris at 1225 Crystal Lake Road, Lutz, Florida. An ACI is designed to blow a curtain of air over the burning material in a container to promote efficient combustion and minimize the emission of smoke and embers. This type of operation will have the potential to generate smoke and dust from the burning and handling of the materials. The EPC does not regulate any zoning, siting, or transportation matters.

**Background:** In the 1970s, the U. S. Environmental Protection Agency created National Ambient Air Quality Standards for several air pollutants to better protect human health and the environment. For over 40 years, EPC staff has monitored for these pollutants, of which ground-level ozone is the most pervasive. Unlike stratospheric ozone which protects us from the sun's harmful rays, ozone is a lung irritant at ground-level. This informational presentation will provide an understanding of what ozone is, why and how EPC staff monitors for it, and ways persons can protect themselves from its effects.
