Subject: Tampa Bay Water's application for a Water Use Permit for the South Hillsborough Production Well

Recommendation: Direct staff not to arbitrate Tampa Bay Water's application for a Water Use Permit for the South Hillsborough Production Well.

Brief Summary: Tampa Bay Water voted on March 20, 2023, to submit an application to SWFWMD for a permit to pump the South Hillsborough County Production Well in the Balm area to provide additional water supply to southern Hillsborough County. Pursuant to the Interlocal Agreement, Tampa Bay Water must wait 30 days to file the application unless the County and EPC vote not to arbitrate. Tampa Bay Water has requested the EPC vote not to arbitrate the application, so it can be submitted to SWFWMD sooner.

Background: In accordance with the provisions of Tampa Bay Water's (TBW) Interlocal Agreement, the Environmental Protection Commission of Hillsborough County (EPC) must decide whether or not to request arbitration on any TBW Primary Environmental Permit application within 30 days of TBW Board's approving submittal of the application to the Southwest Florida Water Management (SWFWMD). A Water Use Permit (WUP) that allows one to withdraw groundwater is defined as Primary Environmental Permit in the Interlocal Agreement. Pursuant to the Interlocal Agreement, TBW must hold the application for 30 days before submittal to SWFWMD, unless the host member governments (e.g. – Hillsborough County and EPC) vote not to arbitrate, thus reducing the 30-day wait period. As described below, the TBW staff asked EPC to schedule a vote as soon as possible.

TBW proposes to convert an existing successful test well in the Balm area into a production well. It is referred to as the South Hillsborough County Production Well and it will provide additional water to meet the growing demand in southern Hillsborough County until the new regional pipeline is completed. The production well is being jointly coordinated with Hillsborough County's South Hillsborough Aquifer Recharge Project (SHARP). The Board of Tampa Bay Water voted on March 20, 2023, to approve submittal of a WUP application to SWFWMD. The proposed WUP application requests an annual average quantity of 2.3 million gallons per day. TBW staff explained to the Board that potential impacts were

evaluated to demonstrate that the project meets the WUP permitting regulations, including but not limited to Section 40D-2.301, Florida Administrative Code.

Tampa Bay Water staff asked the EPC to conduct a special meeting on April 5 during the regular BOCC meeting to help expedite TBW's application filing process. EPC and County staff have reviewed the application and met with TBW and SWFWMD staff. EPC staff recommend that the EPC Commission vote not to arbitrate TBW's application for the proposed Water Use Permit, thus allowing TBW to submit the application sooner.
